 - 15/06024/FUL The Roost Chisbridge Lane** - Frieth Householder application for demolition of existing conservatory, erection of single storey rear extension, first floor side extension, new porch to side elevation & creation of gable to rear elevation
 - 15/05988/FUL Windrush House, Kennet House, Cherwell House, Loddon House, Evenlode House & Thames Court Greenlands Henley Road Hambleden** - Demolition of Kennet House, Cherwell House and changing room building and erection of 1 x two storey and 1 x three storey building each providing 30 bed student accommodation (60 bed in total) with associated landscaping, fencing, gates and new retaining wall to planter area. Installation of 40m2 photovoltaic panels on south facing roof of Windrush House
 - 15/05987/FUL Wood House Chairmakers Way Frieth** - Householder application for erection of rear conservatory
 - 15/05962/CTREE The Old Parsonage Frieth Hill Frieth** - Remove branch ends of tree A multistemmed Sycamore & tree B multistemmed Horse Chestnut overhanging / nearly touching Church View to give 4-5 metres of clearance.
