13/07445/FUL & 13/07446/LBC-St Benedict's & St Albans, St Katharine's Convent, Parmoor Lane, Frieth – Listed building application for the demolition of St Benedict's and erection of a replacement 3 bed dwelling with detached garage, conversion of St Albans into an outbuilding ancillary to The Old Sawmill and associated alterations
