13/07400/LBC – The Manor House, Hambleden - Listed Building application for single storey side/rear extension, single storey rear infill extension & single storey side extension with creation of gymnasium and plant room in basement. Internal and external alterations and replacements, to include improved circulation arrangements through the central (east-west) corridor, lowering of the kitchen pantry floor, alterations to 3 no. existing window openings to form external door-ways, improvements to the master suite, improvements to the layout of bedrooms to the first and second floors and the formation of a new gun room within the existing laundry area. Alternative scheme to that permitted under 13/05801/LBC)
13/07372/FUL & 07373/LBC-Lace Cottage, Frieth Hill -Householder application for construction of single storey rear and side extensions at ground floor with basement and part first floor rear extension.
13/07328/TPO-Garden House Ferry Lane Hambleden-Fell Chestnut on river bank
13/07274/CTREE-Sundawn Chequers Lane Fingest -Fell 2 no. Leylandii
13/07239/FUL -Land Adjacent To Rotten Row Farmhouse Main Road Rotten Row Hambleden -Erection of agricultural outbuilding for use of storage
13/07136/CTREE-Barn End Chequers Lane Fingest -Reduce crown height by 3-3.5 metres and crown spread by 2.5-3 metres and crown thin up to 15% to Cherry tree.
