 - 14/06976/CTREE-The Barn, Innings Road, Frieth** -Prune Field Maple by approximately 1 metre of height and reduce branches overhanging the road by approximately 0.5 metres; reduce height of Acacia by 2 metres and reduce branches overhanging the road / drive and parking area by 1.5 metres, plus remove any dead wood.
